# Arctic Human Health Initiative

July 2005, No. 3

**WHAT IS IPY?** The international polar year (IPY 2007–2008) will be an intensive two year multidisciplinary program of collaborative international science, research and education focused on the Arctic and Antarctic regions. (More info on IPY at [www.ipy.org](http://www.ipy.org)). Human health has never been a focus of previous IPY's.

**WHAT IS AHHI?** The IPY provides a unique opportunity to focus on human health issues of Arctic communities.

The Arctic Human Health Initiative (AHHI) is a project of the Arctic Council which is an eight nation intergovernmental forum for sustainable development and environmental protection in the Arctic.

Circumpolar in scope, the AHHI will expand human health research in the areas of infectious diseases, the human health effects of anthropogenic pollution, the human health impact of climate change, and telehealth innovations.

The AHHI is being coordinated by the US Center for Diseases Control and Prevention's Arctic Investigations Program, together with the International Union for Circumpolar Health and the US National Institutes of Health's Fogarty International Center.

**PROGRESS TO DATE** An expression of intent (EoI) on behalf of the Arctic Council was submitted to the IPY Joint Committee January 14, 2005, and can be viewed at the IPY Web Site [www.ipy.org](http://www.ipy.org) together with other country health related EoIs under cluster #6 Human Issues. The AHHI EoI is JC 914. The official assessment of the AHHI EoI suggested that the AHHI could function as a "core" or umbrella project which would engage other regional national and international partners.

A US National Advisory committee for the AHHI was formed and met in Anchorage, Alaska, February 8, 2005. Potential US Arctic human health related projects and activities that could be undertaken during the IPY were discussed.

An AHHI International Advisory committee was formed and met in Copenhagen, Denmark April 7, to discuss potential linkages and areas of cooperation between human health activities proposed to be undertaken during IPY by researchers in other circumpolar countries and the development of a full proposal to be submitted to the IPY Joint Committee by September 30, 2005.

Alan Parkinson met with David Hik, Executive Director of the Canadian IPY Secretariat May 4th to discuss Canadian IPY human health initiatives, and was briefed on two day meeting held in Whitehorse Yukon Territories which facilitated discussions on Canadian IPY human health research pre-proposals. This meeting also engaged a number of northern and Aboriginal organizations interested in participating in human health research activities during IPY. It is anticipated that there will be close collaboration between the AHHI and Canadian human health initiatives.

**OUTCOMES** From the meetings held in Anchorage (February 6th), Copenhagen (April 7th), the results of the EoI assessments, and discussion with AHHI collaborators, a potential project clustering under an AHHI umbrella can be proposed for further discussion and development of a full proposal for the September 30, 2005 deadline.
